CRCPL request for funding: 500 WiFi Hotspots

To help bridge the homework gap, the Chillicothe & Ross County Public Library would like to obtain 500 T-Mobile WiFi hotspots to distribute to students in Ross County, Ohio, who are lacking adequate Internet connectivity at home. The hotspots will be distributed on first-come, first-served basis for the duration of the 2021-2022 school year. 500 devices will meet the needs of approximately 20 percent of Ross County's high school population.

Educators in all seven school districts in Ross County, Ohio, claim that they have many students who would greatly benefit from this program. Students in our rural areas have no access to high-speed internet, as plans offering approximately 5 mbps down are all that are available in those locations. Many households are sharing this weak connection. Parents use the Internet for work, doctor's appointments, filing for benefits, etc., and students often need Internet for homework and other school requirements. Speeds that low can't handle multiple connections.

Many Ross County students also lack Internet for financial reasons. Ross County's seven school districts qualify for anywhere from 34 to 100 percent free and reduced-price school lunches, signaling a level of poverty that might not allow families to afford an Internet connection.
